NOTIFICATION UNDER SECTION 4

Whereas it appears to the Yang di-Pertua Negeri that any land as shown on Plan No. 798-T-PL-D-LA-C01 is likely to be required for a public purpose, that is to say for the construction of the "Raw Water Pumping Mains, Tuaran"; now, therefore, in exercise of the powers conferred upon him by section 4 of the Land Acquisition Ordinance, the Yang di-Pertua Negeri hereby notifies that the land set out in the Schedule hereto is likely to be required for a purpose, which in the opinion of the Yang di-Pertua Negeri is a public purpose.
